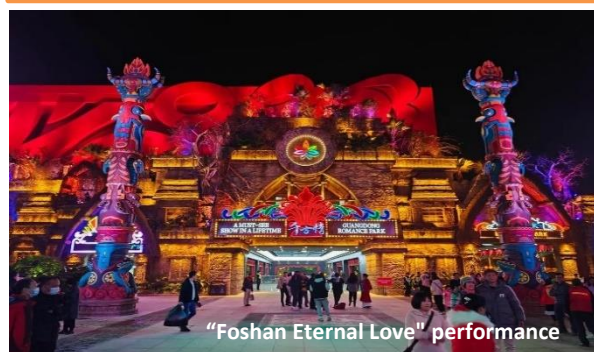

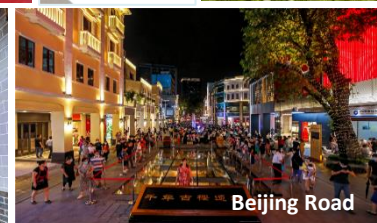

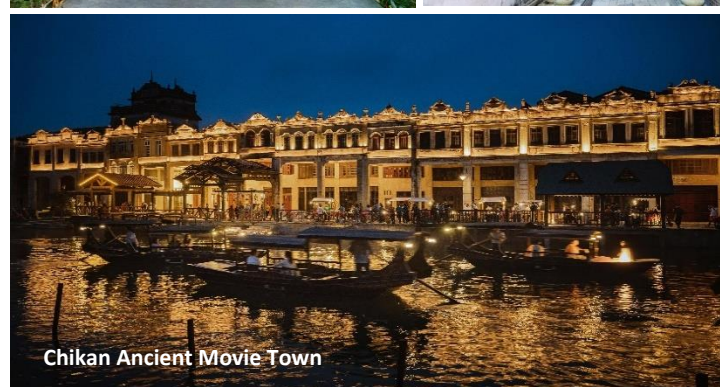

## DAY 1 K. LUMPUR ✈️ GUANGZHOU 🚗 SHENZHEN [MOB/D]

- Assemble at KLIA for flight to Guangzhou.
- Upon arrival, visit **Yongqing Fang**, an old street that was once the economic hub of southern China during the late Qing Dynasty. Now transformed into Guangzhou's trendy new hotspot, it showcases a fusion of tradition and modernity, history, and contemporary style, embodying both the old and modern chic.
- Visit **Bruce Lee's Ancestral Home**, a classic Xiguan-style mansion, now enhanced with modern technology to provide an immersive experience.
- After dinner, enjoy the **night view of the Dafo Temple**. The temple, with its main hall facing south, has been the leading temple in Lingnan for over 300 years. Despite centuries of weathering, it remains well-preserved and is one of the five major temple complexes in the Guangfu region.
- Check into a local hotel in Shenzhen for the overnight stay.
- ★ **Shenzhen – ZTL Hotel or similar**

## DAY 2 SHENZHEN [B/L]

- After breakfast, visit **Gankeng Ancient Town**. The town features historic buildings, watchtowers, and shops and restaurants housed in renovated traditional residences. By the lake, unique stilted buildings are a highlight, along with the 200-year-old Zhuangyuan Mansion and the exquisitely carved Nanxiang Building.
- Next, view the **Qianhai Ferris Wheel**. Standing 128 meters tall, this Ferris wheel is the centrepiece of Happy Harbour and is visible from many parts of the area.
- Explore **Happy Harbour**, a unique urban park that seamlessly integrates bays, green spaces, urban culture, nature, leisure, and commerce.
- Visit the **Michelin Food Street**. This food hub features snacks, desserts, regional delicacies, and full-course meals. All brands here have either earned Michelin stars or been recommended by the Michelin Guide.
- Stroll along **Dongmen Pedestrian Street**, one of Shenzhen's oldest commercial walking streets. Packed with thousands of shops and diverse architectural styles, it has long been a flagship of Shenzhen's commercial scene.
- ★ **Shenzhen – ZTL Hotel or similar**

## DAY 3 SHENZHEN 🚗 ZHONGSHAN 🚗 ZHUHAI [B/L/D]

- After breakfast, visit **Sun Yat-sen's Former Residence**, a two-story building, made of brick and wood, blends Chinese and Western architectural styles. Surrounded by a courtyard and a perimeter wall, its facade reflects Western influences.
- Then, stroll along **Sunwen Pedestrian Street**. The low-rise buildings lining the street are a mix of late 19th and early 20th-century European-style architecture and Lingnan arcade buildings, known as "Nanyang-style architecture" in architectural terms. These buildings, featuring intricate wood carvings, grey sculptures, and Nanyang arcades, form a continuous, harmonized facade.
- View the **Qijiang Bridge**, which has operated a fixed schedule for opening and closing to support Zhongshan's waterway traffic since its construction. This longstanding tradition of timed operation has become a unique attraction, drawing visitors to witness its opening and closing.
- Visit the **Zhuhai Opera House** on Yeli Island along Lover's Road in Zhuhai. Known as the only opera house built on an island in China, it features a design of two shell-like structures, symbolizing the sun and moon, hence, nicknamed "Sun and Moon Shell."
- Stop by **Lover's Road**, a coastal promenade and iconic symbol of Zhuhai. Known for its beauty and charm, it offers a serene place to stroll along the seaside, enjoy the sea breeze, and soak in leisurely moments.
- View the **Fisher Girl Statue** on the picturesque shore of Xianglu Bay in Zhuhai. This iconic statue depicts a young fisherwoman adorned with a pearl necklace and fishing net, gracefully holding a large round pearl high in her hands, exuding a lifelike and endearing expression.
- Explore the **Love Post Office**, a cultural attraction themed around love. Through interactive experiences and themed events, it has been designed as a symbol of romantic culture along the South China Sea.
- After dinner, check into a local hotel for an overnight stay.
- ★ **Zhuhai – Lavande Hotel or similar**

## DAY 4 ZHUHAI 🚗 JIANGMEN 🚗 ZHONGSHAN [B/L/D]

- After breakfast, proceed to **Qimingli** in Jiangmen. This historic site, built over a century ago with funds from overseas Chinese, served as a settlement for returning Chinese immigrants. It stands as a significant monument and historical landmark for understanding the history of the Chinese diaspora. Qimingli is the earliest, best-preserved, and most extensive origin point of overseas Chinese settlements in Jiangmen.

*Remarks: Due to local/religious festivals, and unforeseen circumstances, the sequence of the itinerary is subject to change with/without prior notice.*

- Next, visit **Jiangmen 33 Xu Street**, a symbol of Jiangmen's prosperity and historical evolution. This area is an iconic landmark of the city's history, featuring arcade-style buildings and cobblestone streets. Every brick and tile tells a story of the past, evoking a deep sense of history and cultural heritage.
- Later, head to **Chikan Ancient Movie Town**. Built along the Tanjiang River, the south bank showcases a rural setting, while the north bank reflects urban life. The uniform arcade-style buildings offer a charming blend of Chinese and Western architectural simplicity.
- In the evening, enjoy the Chikan Ancient Town intangible cultural heritage performance - **the Iron Flower Fireworks Show**. This traditional large-scale fireworks display, rooted in ancient Chinese craftsmanship, originated from the process of casting utensils. Its unique artistry captivates audiences with its enchanting beauty.
- Check into a local hotel for an overnight stay.
- ★ **Zhongshan – Lighting Era Hotel or similar**

## DAY 5 ZHONGSHAN 🚗 SHUNDE 🚗 FOSHAN [B/L]

- After breakfast, visit the **Shunde Grand Archway**, reputed as the largest archway in Asia. Made of stone and adorned with intricate carvings, it is said to surpass the height of the Arc de Triomphe in France.
- Continue to visit the **Louvre International Furniture Exhibition Center** [Louvre Casa] in Shunde, China's first furniture mall rated as a National 4A Tourist Attraction.
- Head to **Star City Plaza**, where the plaza's floor, made of premium marble, features eleven zodiac signs inlaid with intricate designs. A twelfth zodiac symbol, hidden like a puzzle reminiscent of the Da Vinci Code, invites visitors to observe and imagine, giving the plaza its unique name.
- In the evening, visit the **Foshan Thousand-Year Culture Theme Park** and enjoy a **VIP seat for the large-scale "Foshan Eternal Love" performance**. The park offers an immersive experience—one moment, you're walking through an ancient city, touching the pulse of Guangdong's millennia-old culture; the next, you're stepping into a southern Chinese mystical realm and encountering the legendary Baiyue culture.
- Check into a hotel in Foshan for an overnight stay.
- ★ **Foshan – Foshan Hilton hotel or similar**

## DAY 6 FOSHAN 🚗 GUANGZHOU [B/L/D]

- After breakfast, visit the **Foshan Ancestral Temple**, also known as Beidi Temple. Dedicated to Zhenwu, the Dark Warrior of Daoism, this temple showcases the prosperity of ancient Foshan and is a precious historical heritage site.
- Next, tour the **Wong Fei-hung Memorial Hall**, designed in the style of a large late-Qing Lingnan ancestral house. Built to honor the legendary martial artist Wong Fei-hung, it features exhibition halls, a movie theater, and a martial arts practice hall displaying his life and achievements.
- Explore **Lingnan Tiandi**, home to one of China's most complete clusters of ancient buildings. Highlights include 22 historical and cultural landmarks such as the Jian Family Villa, Marriage House, Confucian Temple, and Li Zhongsheng Hall's ancestral shop.
- Proceed to **Guangzhou's Flower City Square**, often called the city's living room and the largest square in Guangzhou.
- View the iconic **Canton Tower**. Including its antenna, the tower stands 600 meters tall and is one of the world's tallest towers. It offers panoramic views of Guangzhou from the top [entrance ticket not included].
- Visit **Haixinsha Island**, located at Pearl River's Pazhou section. Known for its stunning night views, it features a spectacular interplay of lights with the Flower City Square and the colorful illumination of the Canton Tower across the river.
- After dinner, enjoy free time shopping at **Beijing Road**. As the birthplace of Guangzhou's urban construction, this street has been the city's commercial center for over 2,000 years. It remains a vibrant hub of culture, history, and commerce, showcasing Guangzhou's rich heritage and modern dynamism.
- ★ **Guangzhou – Hampton by Hilton Hotel or similar**

## DAY 7 GUANGZHOU ✈️ K.LUMPUR [B/MOB]

- After breakfast, proceed to the airport for flight back to Kuala Lumpur.

## Tour Terms and Conditions

Passengers are deemed to have read, understood and accepted the following conditions. The organizer shall be known as “The Company” in the conditions below.

### **RESERVATIONS AND DEPOSIT**

A deposit of RM 500 - RM 3,000.00 (subject to tour package selected) is required upon booking. The balance is to be paid in full 31 days before departure. Failure to comply with this may result in an automatic cancellation of reservation and a forfeiture of deposit. Deposits are applicable for the tour booked only and are not transferable.

### **CREDIT CARD / CHARGE CARD**

An administrative fee is chargeable for payments by credit or charge card.

### **CANCELLATION / AMENDMENTS**

- 1) Cancellation of a confirmed booking must be made in writing to avoid misunderstanding.
- 2) Postponement / transfer of tour will be deemed to be a cancellation and will be charged accordingly.
- 3) Cancellations during peak, festive or holiday seasons will result in 100% forfeiture of the booking deposit.
- 4) For each amendment made after a booking has been confirmed, a fee will be charge by the respective airlines and service suppliers. An amendment does not constitute a transfer to another tour.
- 5) Deposits paid during travel fairs are non-refundable and will be forfeited if passenger cancels tour.

As The Company is acting as an agent for the service suppliers, all arrangements are still SUBJECT TO CONFIRMATION even after a deposit or full payment has been made. When the arrangement cannot be confirmed, The Company will endeavour to notify passengers as soon as possible and a full refund will be made. The Company shall henceforth not bear any other liability or responsibility.

### **TOUR FARE INCLUDES (GROUP TOURS ONLY)**

- Unless stated otherwise, the fare includes:-
- Return economy class group tour air ticket.
  - Return airport transfer (airport to hotel and vice-versa)
  - Hotel accommodation on twin-share or triple-share basis. Single room occupancy is at additional cost.
  - When booking triple-share rooms please note that third bed may be a “roll-away” bed.
  - All meals are specified in the itinerary. If the selected carrier’s flight time does not allow for certain meals to be taken, there shall not be any refund for meals not consumed.
  - Baggage allowance is 20 kilos per passenger, unless specified otherwise by the airline.
  - Group materialization and services of a tour manager is subject to a minimum group size of 15 paying adults (For the purpose of computation, 2 children constitute as 01 adult)

### **TOUR FARE EXCLUDES**

- Visa fees
- Airport taxes + fuel surcharges (Subject to change without prior notice)
- Extra baggage allowance
- Meals, beverages, room services or any others not specified in the itinerary.
- Gratuities to driver, tour guide or tour manager.
- Other incidental items of a personal nature.

Tour fares are based on current airfares, service prices, government tax and exchange rates, applicable at time of print or quotation and are subject to change with or without prior notice.

### **CHILD FARE**

Eligibility: Below 12 years (on the date of departure) Child fare is based on sharing a room with two adults. There will be an additional cost for child sharing one room with an adult.

### **ACCOMMODATION**

In the event the accommodation booked or requested is not available, every effort will be made for an alternative accommodation of similar standard. The Company shall henceforth not bear any other liability or responsibility.

### **SPECIAL REQUEST**

If there are any requests regarding special meals, dietary requirements, adjoining rooms and so on, please inform The Company when booking. Such requests are subject to confirmation and availability.

### **TRAVEL DOCUMENTS**

It is the passenger’s responsibility to ensure that his/her international passport has a validity of at least 6 months from the date of departure. Relevant visas and vaccinations may be required. An administrative fee of RM50.00 per person will be levied for any cancellation due to non-approval of visas.

The Company will, wherever possible, assist you to obtain the necessary visas. Service charge and visa fees will be borne by the passenger. The Company does not guarantee the approval of the visa application. If for any reason, application for visa or exit permit is rejected, a full refund of all monies paid (excluding visa application fees) will be made,

if the result of the rejection is made known to the Company at least 30 days prior to departures.

The Company cannot be held responsible for any expenses, reimbursement or refund of any tour fares if passenger is refused entry by any country on the tour for whatever reasons, including lack of necessary visas.

### **SEAT ROTATION**

For the convenience of all members of the group, passengers are requested to rotate their seating arrangements on the coach during the period of the tour. Please co-operate when called upon to do so by the tour leader/guide.

### **TRAVEL INSURANCE**

Strongly recommended with respect to such areas as trip cancellation, personal baggage, personal accident, injury and illness. Under no circumstance is The Company to be construed as a carrier under contract for safe carriage of the passenger or her/his baggage and belongings. Our staff will be pleased to assist in the enquiries of any travel insurance.

### **EXTENSION OF STAY / DEVIATION**

Extension of stay / deviation may be permitted at the end of the tour, subject to validity and restrictions of air ticket, seat confirmation and availability of hotel prior to the commencement of tour. It is the passenger’s responsibility to hold firm confirmation for their return flight. When extension of stay / deviation cannot be confirmed three weeks prior to the group’s departure date, the passenger is deemed to be taking the original tour schedule. In the event that the original arrangement has been changed by The Company during the process, any extra cost will be borne by the passenger.

Extension of stay / deviation will be at the passenger’s own expense and transfer to airport will not be provided. Alteration on the routing or date of travel is at the passenger’s own risk. No refund will be made to such a person for unused air tickets or for any meals and sightseeing tours or accommodation not used in part or full.

The air ticket issued is a special ticket, restricted to a specific airline only. It is non-negotiable, non-endorsable, non-reissuable, non-refundable and non-reroutable.

### **OPTIONAL TOURS**

Optional tours are arranged at the customer’s request and confirmed with their consent. The Company is only acting as an agent for the service suppliers; and does not accept any responsibility for said optional tour(s).

### **RESPONSIBILITY**

The Company acts only as an agent for the transportation companies, hotels and other principals for the tour programmes. They accept no responsibility for injuries, damage, accident, loss, delay, quarantine, theft, customs regulations, strikes, changes in itinerary, deportation or refusal of entry by Immigration Authorities resulting from improper travel documents, possession of unlawful items or irregularities that may be caused to person or property. Any losses or expenses are the responsibility of the passenger. All proper travel documentation is the sole responsibility of the passenger.

The Company reserves the right to alter itineraries, travel arrangements, hotel reservations etc. If it is necessary or in the case of force majeure, The Company reserves the right to cancel any tour prior to the date of departure for any reasons, including insufficient number of participants (minimum 15 paying adults). Should this happen, that entire payment shall be refunded without further obligations on the part of The Company.

The Company will recommend an alternative tour, preferably to the same destination or other destinations. Should the passenger decide not to accept the alternatives, all monies paid shall be refunded in full by The Company without further obligations.

The Company also reserves the right to require any individual to withdraw from the tour if deemed his/her act of conduct is detrimental to or incompatible with the interest, harmony and welfare of other passengers and the tour as a whole. Should this right be exercised, all monies paid shall be refunded in full by The Company to the passenger. The Company shall be under no further liability thereafter to any such person.

No tour managers / guides or other employees or agents of The Company are authorized to commit The Company to any liability whatsoever and The Company will not be bound by any statement unless in writing and signed by a management executive of The Company.

The Company reserves the right to take the films and photographs of passengers while on tour with The Company to be used for brochures, advertising or publicity material without obtaining any further consent from the passenger.

It is the prerogative of The Company to cancel the tour in whole or in part if there is a real possibility that the life, limb or property of any person may be endangered. The Company will refund in whole or in part as the case may be, and will not be responsible for any further liability.
